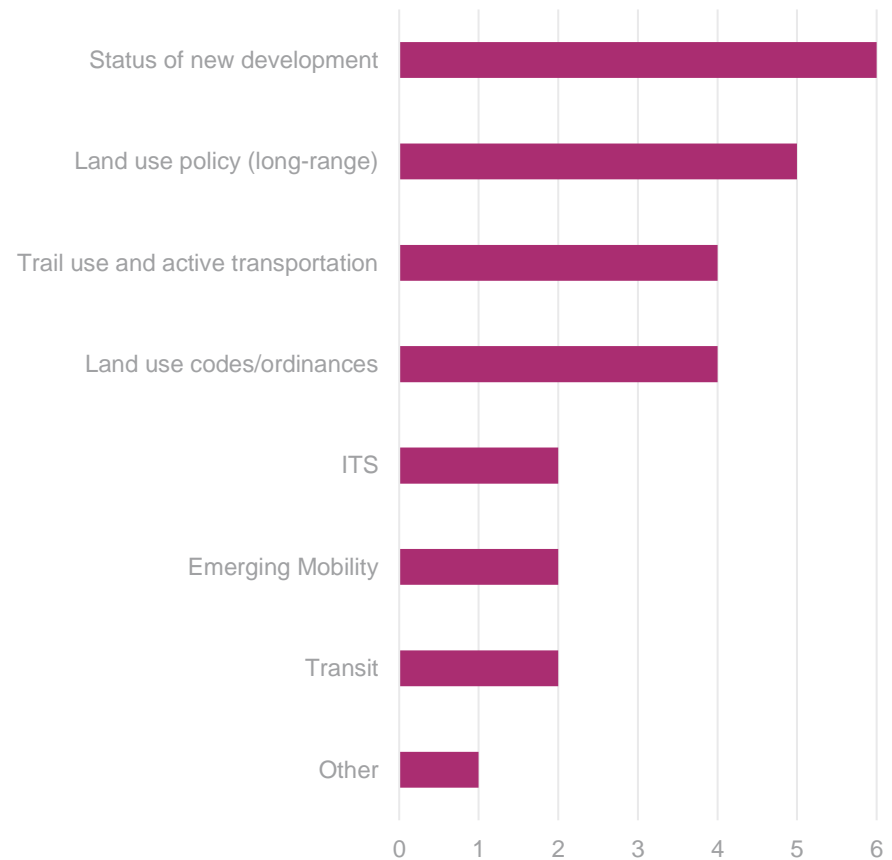
Do you see a need to modify the purpose of this group moving forward? If so, please explain.

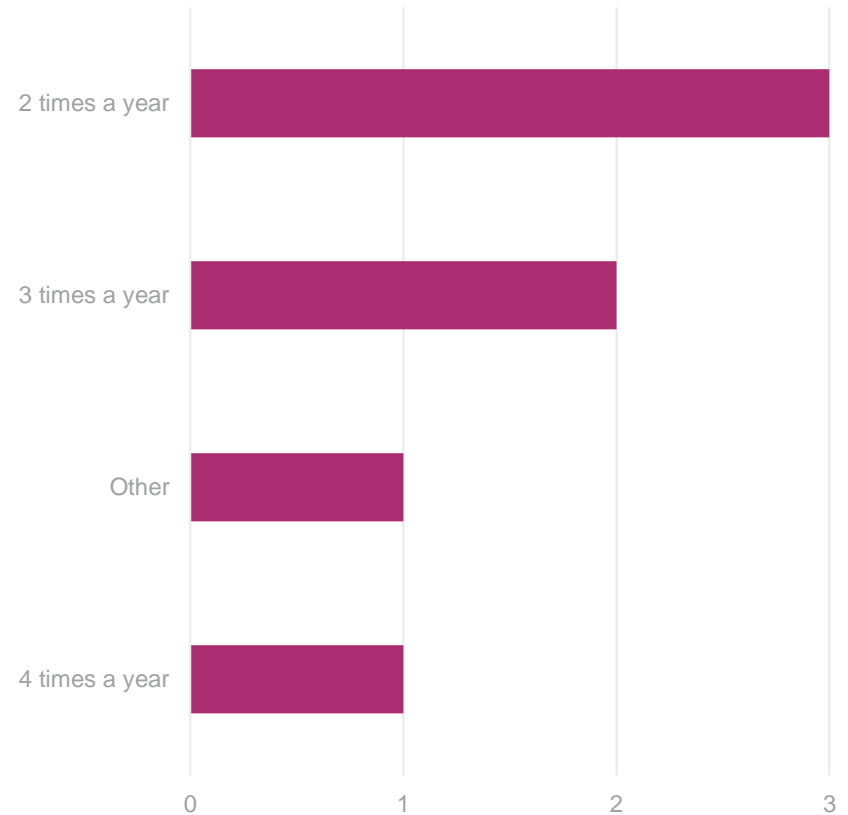

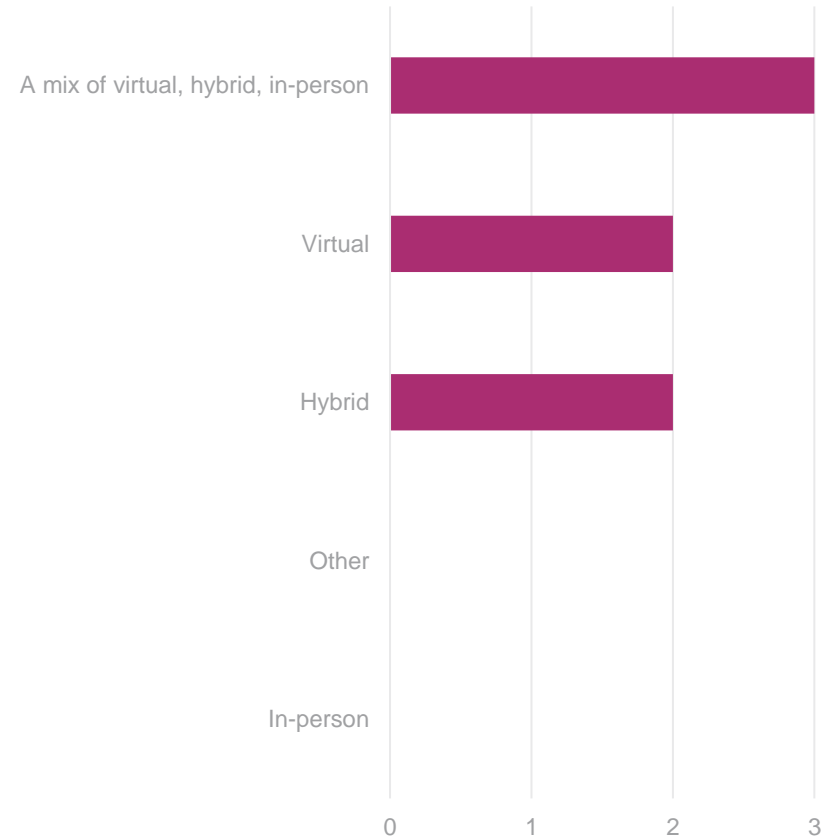

What meeting format would you prefer for future meetings?

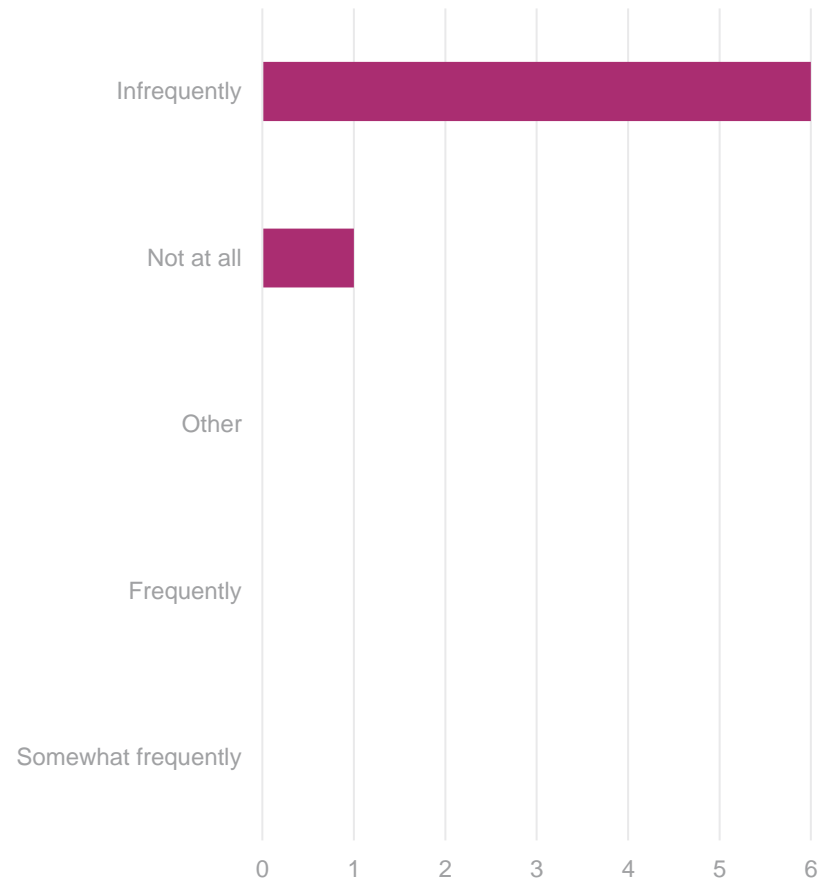

Are you using the website?

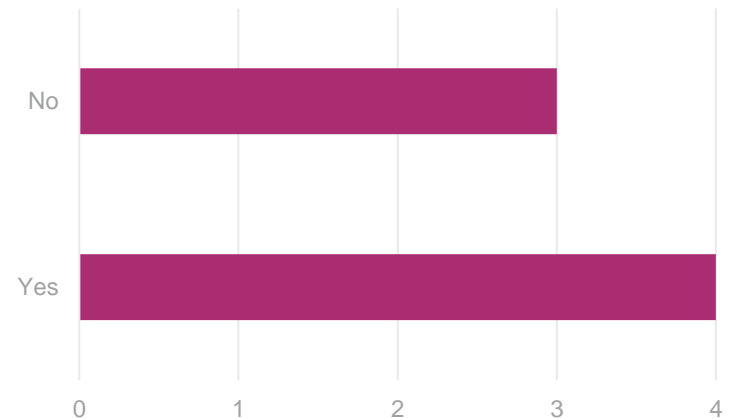
