## **Around the Room**

#### Town of Huntersville

Jack Simoneau and Heather Maloney gave updates for the Town of Huntersville:

- The town is developing the Huntersville Mobility Plan which will combine many of the
  existing mobility, ped/bike, and other transportation plans. It should be completed by
  November 2023.
- In Birkdale Village, there are several rezoning requests / on-going development projects, including:
  - $\circ$  A rezoning request for a 7-story building
  - o Current development for a hotel on the Birkdale golf course
  - o Current development of a one-story apartment building
- As NC-73 is widened, the Town of Huntersville has concerns about the safety/practicality of several proposed pedestrian road crossing at locations including:
  - o Lindholm Drive
  - o Birkdale Commons
  - McDowell Greenway
  - o Holly Point
- Closer to the intersection with Davidson-Concord Rd, there are several proposed developments. The primary rezoning request is for the 'Lagoon Project'. This would include: Apartments, town homes, a conference center, hotel, retail, commercial

shops, and single-family housing. The development is inconsistent with the Town of Huntersville's plans (and the Town of Cornelius' plans for the bordering area). The zoning decision should be made in 2 months. Other municipalities expressed interest in sharing their zoning and older planning efforts to provide context on this area to the Town of Huntersville board members.

#### **Town of Cornelius**

Aaron Tucker gave updates for the Town of Cornelius:

• A 170-bedroom hospital was just approved at West Moreland and U.S. 21. The hospital will be built on 30 acres of a 100-acre site, and it should be completed by 2025.

#### Town of Davidson

Jason Burdette gave updates for the Town of Davidson:

- Summer Walk, a 40 town-home development, is currently underway.
- The town has a new Town Hall! They have moved from their Main Street location to an adapative reuse facility in an old school

#### City of Kannapolis

Richard Smith gave updates for the City of Kannapolis:

- Our Council adopted a text change to our KDO to reduce the preservation corridor along Hwy 73 from 50' to 35' (the protection area remains, but the preservation area was reduced to mirror the anticipated NCDOT future r/w width more accurately)
- Recently completed Bojangles Renaissance Square (near Mecklenburg County line)
- Redwood Living Davidson Hwy –78 apartments (southeast corner of the intersection of Hwy 73 and Kannapolis Parkway) plan review completed; construction pending.
- Biscayne self-storage facility Our Board of Adjustment issued a special use permit for storage facility near the corner of Biscayne and Hwy 73; further retail plans for this site are in the works as well.
- 85 Exchange development underway- southwest corner of 73 and Kannapolis Parkway; mixed-use project
- Convenience store in Gateway Business Park (located just northeast of 73 and Parkway intersection) under construction.

#### **Cabarrus County**

Phil Collins gave updates for Cabarrus County:
